Scholarship Application

The central object and purpose of the Huntsville/Madison County Builders Foundation shall be to engage in educational, charitable and scientific activities dedicated to the improvement of the residential housing industry and provision of housing for the public through educational, scientific, charitable and research efforts. To effectuate this object and purpose, the Foundation may present scholarships to those persons pursuing a level of higher education in a housing related field.

GENERAL SCHOLARSHIP FUND

I. Eligibility - Any person pursuing a level of higher education in a housing industry related field is eligible to apply for a scholarship.

Scholarship recipients must:

- ◆ Be accepted by an accredited two year junior or community college, four year college or university, or state accredited vo-tech school; or an enrolled undergraduate student; and

- ◆ Be pursuing study in a housing industry related field. Such fields may include architecture, business, drafting, building science, or other housing industry related studies; and

- ◆ Students must be residents of Madison County or contiguous counties.

II. Selection - Scholarships are awarded on the basis of academic excellence, service/activities, career goals, and financial need.

III. Awards/Application - Awards will be made by the selection committee pursuant to approval by the Foundation Board of Directors.

Foundation Scholarships shall be for one academic year and shall be in amounts determined by the Committee based on the recipient's financial situation, the relative costs of the schools involved and the amount of available funds.

Interested persons must fill out this application in its entirety and mail it to the H/MCB Foundation. Scholarship recipients will be announced at a general membership meeting of the Huntsville/Madison County Builders Association.

Scholarship Award letters will be mailed to the educational institution no later than August 1st of the year presented. Note: Previous recipients must reapply each year.

WOMENS COUNCIL DESIGNATED SCHOLARSHIP FUND

Eligibility Requirements:

- Applicant must be an employee, child of an employee or a child of a member in good standing of the H/MCBA.

- Applicant must be majoring in building related fields or taking classes pertaining to the homebuilding industry.

- Applicant must be accepted by an accredited two year junior or community college, four year college or university, or state accredited vo-tech school, or an enrolled undergraduate student.

- The scholarship award may be used by the student for tuition, books, equipment or room and board, but it must be dispersed by the school.

- Applicant may not receive more than four (4) Women's Council Designated Scholarship Awards while pursuing their education. Applicant may not receive more than one (1) Women's Council Designated Scholarship Award with an undeclared or undecided major field of study.

- Family members of committee members will not be considered for scholarship funds.

Interested persons must fill out this application in its entirety and mail it to the H/MCB Foundation.

Scholarship recipients will be announced at a general membership meeting of the Huntsville/Madison County Builders Association.

Scholarship award letters will be mailed to the educational institution no later than August 1st of the year presented. Note: Previous applicants must reapply each year.
